#### Great-West GroupNet Online Services for Plan Members Access Agreement

In order to complete the registration process you must read and agree to the following terms and conditions.

The Online Services for Plan Members access available to you on this site ("Online Services for Plan Members Access") shall be governed by this Online Services for Plan Members Access Agreement (the "Agreement"). By registering for Online Services for Plan Members Access, you acknowledge that you have read, understood and agreed to be bound by the terms and conditions set forth in this Agreement, as amended from time to time. If you do not agree with the terms and conditions set forth in this Agreement, do not register for Online Services for Plan Members Access.

By registering for Online Services for Plan Members Access, you are also verifying that the information that you have entered to confirm your identity in the registration process belongs exclusively to you and that you are registering only your own account.

#### Use of Great-West GroupNet Online Services for Plan Members Access

- Great-West authorizes you to use Online Services for Plan Members Access solely for purposes of transacting business with Great-West. Great-West reserves the right to suspend any services provided under Online Services for Plan Members Access for violating any of these terms and conditions. In order to use this site, you must have attained the minimum prescribed age in the jurisdiction in which you are resident to contract for the products and services.
- Any information or transaction accessed, transmitted or performed through Great-West which is related to any other product or service shall be subject to any terms, conditions or restrictions applicable to such product or service.

#### Use of Logon ID and Password

- Upon registration, you will select a logon ID and password which shall constitute your electronic signature ("Electronic Signature") in your dealings with Great-West. You authorize Great-West to execute any instructions which are provided pursuant to your Electronic Signature. You acknowledge and agree that your Electronic Signature is the legal equivalent to your written, signed instructions.
- You agree that the web pages you access shall constitute written documents and that clicking or otherwise electronically activating "accept", "register", "submit", "continue", "ok" or any other similar icons on such pages according to on-line instructions shall have the same legal effect as if you had signed and delivered hard copy versions of such documents to Great-West.
- You agree to be liable for all uses of your Electronic Signature and you acknowledge that Great-West shall not be required to verify the actual identity or authority of any user of your Electronic Signature. You further agree to be liable for any loss caused as a result of or in connection with, any use or unauthorized use of your Electronic Signature, including any transaction performed, or information obtained through such use, even without your knowledge or consent.
- You agree to take appropriate security measures to protect the confidentiality of your Electronic Signature and to guard against misuse of your information. You will notify Great-West immediately should the confidentiality of your logon ID or password be in jeopardy or that there has been unauthorized use of your Electronic Signature.

#### Records

- All transaction records for Online Services for Plan Members Access transactions are subject to verification and acceptance by Great-West. Such records, whether electronic or otherwise shall be conclusive and binding on you for all purposes in the absence of clear proof that the records of Great-West are incomplete or incorrect.

#### Amendments

- Great-West may amend the content of this site and any or all of the services provided under the Online Services for Plan Members Access service at any time, with or without notice to you. Any or all of such services may periodically be unavailable to you in order to allow for maintenance, updates or other reasonable causes, including causes beyond the control of Great-West.
- Great-West may amend this Agreement at any time without prior notice to you. Any changes to this Agreement will be posted on this site from time to time. By accessing or using the Online Services for Plan Members Access service, you agree to be bound by any such change.

#### **Cancellation of Online Services for Plan Members Access Service**

- You may cancel your Online Services for Plan Members Access at any time by providing notice in writing or by electronic means to Great-West at least thirty (30) days prior to the effective date of cancellation.
- Great-West may cancel any or all of the services provided by, or your access to, Online Services for Plan Members Access at any time without notice to you. Great-West will have no liability for any loss, damage or inconvenience that may result from cancellation.

#### **Website Terms of Use**

- You agree to be bound by all of the terms and conditions contained in the Legal, copyright and trademark information page which terms and conditions are incorporated herein and form an integral part of this Agreement.

#### **General**

- This Agreement shall be governed by the laws of the Province of Manitoba and the laws of Canada applicable therein. You agree that any legal actions arising under this Agreement must be commenced in the courts of the Province of Manitoba.
- If there is any inconsistency or conflict between the terms and conditions of this Agreement and those of any predecessor agreement that you may have entered into relating to any access method offered by Great-West, this Agreement shall prevail.
